ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Capital Area Regional Public Facilities District from January 1, 2010 through December 31, 2011.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Financial sustainability
- Disbursements
- Open Public Meetings Act

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE DISTRICT

The Capital Area Regional Public Facilities District is a special taxing district created by an inter-local agreement between Thurston County and the cities of Olympia, Lacey and Tumwater for the purpose of financing two regional event centers, the Lacey Regional Athletic Complex and the Olympia Hands On Children's Museum. District revenue is from a 0.033% sales and use tax authorized pursuant to RCW 82.14.390 for 25-years starting in 2003.

The District is governed by a seven-member Board of Directors composed of members appointed by the county and cities. The District has no employees; the city of Lacey performs accounting and administrative functions for the District.
