NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THURSTON COUNTY, WASHINGTON AS FOLLOWS:

1. That the proposition for the incorporation of the CITY OF LACEY as a City of the Third Class, having a population as nearly as may be stated of 8860 inhabitants, is hereby declared to have carried in said special election, having received a majority of all votes cast in said special election, and said City of Lacey is hereby declared to be incorporated as a City of the Third Class, comprised of the following territory:

Beginning at the Southwest corner of Thurston County Fire Protection District No. 3 to an intersection of the east City Limits of Olympia in Section 25, Township 18 North, Range 2 West, W.M.; thence Easterly along the Southern line of said Section 25 to the Southwest corner of Section 30, Township 18 North, Range 1 West, W.M.; thence easterly along the southern line of said Section 30 to the southwest corner of Section 29, in said township; thence easterly along the southern line of said Section 29 to the southwest corner of Section 28, in said township; thence easterly along the southern line of said Section 28 to the southwest corner of Section 27, in said township; thence easterly along the southern line of said Section 27 to its intersection with the westerly margin of Carpenter Road, near the southeast corner of said Section 27; thence northerly and westerly along the western margin of Carpenter Road to the center line of Secondary State Highway #510; thence northerly along the western margin of Carney Road to its intersection with the southern margin of Draham Road; thence southerly and westerly along the south margin of the Draham Road extended westerly to an intersection with the easterly margin of N.E. 36th Street (Lilly Road); thence southerly along the eastern margin of 36th Street to the center line of Secondary State Highway #510 (Pacific Avenue; thence easterly along the center line of said highway to its intersection with the westerly right of way of the Chehalis Western Railway Company; thence southerly along the said westerly right of way to the southeast corner of the northwest quarter of the northwest quarter of Section 20, Township 18 North, Range 1 West, W.M.; thence westerly to the city limits of Olympia; thence along said city limits to the point of beginning.

2. That the following named persons are declared to be duly elected officers of the City of Lacey, under the Mayor-Council form of government, and entitled to assume office on the first Monday following issuance of the certificate of election by the County Auditor, and shall continue in office until their successors are elected and qualified as provided by law.




3. That a certified copy of this Resolution be filed with the Secretary of State at Olympia, Washington, and that from and after such filing, incorporation shall be deemed complete.
