2019 Volunteer Services Agreement

This Agreement is made, by and between the City of Lacey, a municipal corporation, hereinafter referred to as the "CITY" and, hereinafter referred to as the "VOLUNTEER GROUP

The purpose of this Agreement is to outline the responsibilities of the CITY in providing volunteer opportunities, and to create an understanding between the CITY and the VOLUNTEER GROUP.

- 1. SCOPE OF SERVICES** This Agreement shall apply to persons and organizations voluntarily performing non-compensated services for the CITY, including but not limited to, practical work experience, recreational programs, senior programs, police resource centers, and academic internships.
- 2. NON-COMPENSATED SERVICES:** It is further understood that this Agreement shall not in any way constitute nor create an employer/employee relationship between the CITY and the VOLUNTEER GROUP or the CITY and any individual member(s) of the VOLUNTEER GROUP. The CITY shall not be responsible for, or liable for, nor shall the VOLUNTEER GROUP be eligible to receive, any compensation or benefits as a result of this Agreement **EXCEPT** for State Labor and Industries Industrial Insurance medical aid coverage.

The VOLUNTEER GROUP is responsible for directly supervising the activities of its members, agents or associates. While performing services for the CITY, VOLUNTEER GROUP members shall:

- A. Complete an individual waiver form prior to performing volunteer service for the CITY;
- B. Abide by all CITY policies regarding personal conduct while performing volunteer services;
- C. Perform volunteer services in a safe, responsible manner in accordance with the description of service;
- D. Dress appropriately for weather and site conditions (including sturdy shoes & work gloves);
- E. Immediately report any injuries or illnesses incurred during the volunteer event, no matter how minor, to CITY personnel;

- F. Refrain from contacting any objects that are hazardous or suspected to be hazardous. (Hazardous objects include, but are not limited to: syringes, hypodermic needles, broken glass or exceptionally large, heavy or unyielding objects);
- G. Immediately report the location of any objects that are hazardous or suspected to be hazardous, to CITY personnel;
- H. Not have any children under the age of 14 present with the VOLUNTEER GROUP;
- I. Provide appropriate supervision any minors under the age of 18 who are a member, agent or associate of the VOLUNTEER GROUP or who accompany any member, agent or associate of the VOLUNTEER GROUP.

3. WASHINGTON STATE LABOR AND INDUSTRIES The CITY will include the VOLUNTEER GROUP's service hours to Washington State Labor and Industries for coverage of volunteer workers.

4. WAIVER In consideration of the VOLUNTEER GROUP and its members, agents and associates being permitted to perform services on City property, the VOLUNTEER GROUP agrees to defend, indemnify and hold harmless the City of Lacey and its officials, employees and agents from any damage, claim or lawsuit for injury, illness, damage or loss of any kind to anyone, including members of our organization, that might arise out of our activities or the actions of any individuals of our group, except for injuries or damages caused by the sole negligence of the City.

5. TERM The term of this agreement is from **January 1, 2019.**
